("HBK Fund") and HBK Offshore Fund Ltd. ("HBK Offshore Fund"). Accordingly, Fund and Offshore Fund have no beneficial ownership of such Securities.
- (2) Investments' power is exercised by its general partner, HBK Partners II L.P., whose general partner is HBK Management L.L.C.

The Reporting Person and the Controlling Persons are sometimes hereinafter collectively referred to as the "Item 2 Persons."
