On May 8, 2006 SiriCOMM, Inc. issued a press release announcing that it entered into a network access services agreement with ACS Government Solutions, Incorporated ("ACS") an affiliate of Affiliated Computer Services, Incorporated, to provide data access at each of the 260 PrePass weigh station sites in 25 states. Under the terms of the three year agreement, ACS will purchase network access services from SiriCOMM for the benefit of its HELP, Inc. contract for automated vehicle identification and weigh station bypass.
