RSUs are granted under the Fresh Del Monte Produce Inc. 2014 Omnibus Share Incentive Plan. Each RSU represents a contingent right (6) to receive one ordinary share of FDP. The RSUs vest in five equal annual installments on each of 8/3/2016, 8/3/2017, 8/3/2018, 8/3/2019 and 8/3/2020.
