PLAN OF DISTRIBUTION

On April 7, 2003, we will issue and sell 265,816 shares of our common stock to Acqua Wellington North American Equities Fund, Ltd. pursuant to the Prospectus as supplemented by this Prospectus Supplement and pursuant to the terms of the common stock purchase agreement entered into between Acqua Wellington and us on August 15, 2001, as amended. The common stock will be purchased at a negotiated purchase price of \$11.40 per share. We will pay Reedland Capital Partners, an Institutional Division of Financial West Group, a fee of \$30,303 in consideration of placement agent services related to this purchase by Acqua Wellington.
