- (1) On April 1, 2013, the reporting person filed a Form 4/A reporting 300,000 shares were acquired and 1,242,211 shares were beneficially owned following such acquisition. However, because 60,000 of these shares had previously vested, the correct number of reported shares is 240,000. In addition, the number of securities beneficially owned by Mr. Rogers was reduced by 60,000 to 1,182,211. This 60,000 share reduction in the amount of securities beneficially owned by Mr. Rogers reduces the number of shares reported as beneficially owned by him following the reported transaction by 60,000 in each subsequent Form 4 filed by Mr. Rogers prior to the date of this Form 4/A.
