Extension of the validity of the memorandum of understanding with Oi Group and Anatel's approval of the transaction

Portugal Telecom (PT) informs that Anatel, the Brazilian telecoms regulator, approved the transaction associated with the strategic partnership established between PT and Telemar Participações and its subsidiaries (Oi Group) and the corresponding investment of PT in Oi Group.

Additionally, further to the press release disclosed to the market on 28 July 2010, PT hereby informs that it has agreed to extend, for an additional similar period of 90 days, the validity of the memorandum of understanding entered into on the aforementioned date with a view to establishing the basis and principles of the negotiations of a strategic partnership between PT and Oi Group. PT further informs that the negotiations with Oi Group and its shareholders are developing in a satisfactory manner for the development of the said strategic partnership.

PT will disclose additional information on this matter whenever it deems necessary.
