As ISS said in its report last week and reiterated today, *The dissidents have made a compelling case that a change in the composition of the board is necessary, and have proposed a slate of nominees that are well positioned to effect this change. Thus, shareholders should vote FOR the five dissident nominees Chase, Golub, Kurz, McManus, and Smith on the GREEN CARD.*

Change is coming to Hess to the benefit of all shareholders. We encourage everyone to disregard Hess s last-ditch, desperation tactics and focus on the opportunities ahead for this Company and its shareholders.
