**Item 4.01 Changes in Registrant's Certifying Accountant.**

On March 11, 2014, Maui Land & Pineapple Company, Inc. (the "Company") filed a Current Report on Form 8-K reporting that the Audit Committee of the Company had selected Accuity LLP to serve as the Company's independent registered public accounting firm for fiscal year 2014, replacing Deloitte & Touche LLP, but that Deloitte & Touche LLP would complete their audit of the Company's consolidated financial statement for the year ended December 31, 2013. On March 20, 2014, Deloitte & Touche LLP concluded their audit of the Company's consolidated financial statements for the year ended December 31, 2013.

The reports of Deloitte & Touche LLP on the Company's consolidated financial statements for the years ended December 31, 2013 and 2012 did not contain an adverse opinion or a disclaimer of opinion and was not qualified or modified as to uncertainty, audit scope, or accounting principles, other than containing an explanatory paragraph regarding the Company's ability to continue as a going concern.

During the years ended December 31, 2013 and 2012 and through the date of this Current Report on Form 8-K, there have been no disagreements with Deloitte & Touche LLP on any matter of accounting principles or practices, financial statement disclosure or auditing scope or procedure, which disagreements, if not resolved to the satisfaction of Deloitte & Touche LLP, would have caused them to make reference to the subject matter of the disagreement in connection with their reports. During the years ended December 31, 2013 and 2012 and through the date of this Current Report on Form 8-K, there were no reportable events as that term is described in Item 304(a)(1)(v) of Regulation S-K.

The Company has requested Deloitte & Touche LLP to furnish it with a letter addressed to the Securities and Exchange Commission stating whether it agrees with the above statements. A copy of that letter is attached as Exhibit 16.1 to this Current Report on Form 8-K.

During the years ended December 31, 2013 and 2012 and through the date of this Current Report on Form 8-K, neither the Company nor anyone on its behalf has consulted with Accuity LLP regarding either:

1. The application of accounting principles to a specified transaction, either completed or proposed; or the type of audit opinion that might be rendered on the Company's financial statements; or
2. Any matter that was either the subject of a disagreement or a reportable event, as each term is defined in Items 304(a)(1)(iv) or (v) of Regulation S-K, respectively.
