**Item 3.02 Unregistered Sales of Equity Securities.**

On March 5, 2015, NGL Energy Partners LP (the *Partnership* ) and certain of its wholly-owned subsidiaries entered into Contribution and Purchase Agreements (collectively, the *Agreements* ) to acquire three saltwater disposal facilities (the *Acquisition* ). As consideration for the Acquisition, the Partnership issued 1,322,032 common units to the sellers. In issuing common units pursuant to the Agreements, the Partnership intends to rely on an exemption from registration under Section 4(a)(2) of the Securities Act of 1933, as amended.
