- (1) Reporting person deferred 2010 performance bonus pursuant to the 1998 Long Term Incentive Plan - bonus deferral totalled 4662.522 shares and company match totalled 1165.63. Reporting person deferred previous bonuses. The company match vests ratably 33%, 33% and 34% per year over a 3 year period. Special common shares units vested at 12/31/10 were 33,290.48. The bonus was approved on March 4, 2011 and we have calculated the deferral using the March 4 stock price. Cash bonuses will be paid on March 11, 2011.
