- (1) Includes 142,477 shares acquired under the Biogen Idec Inc. employee stock purchase plan on 9/28/2012, 12/31/2012, and 3/28/2013. The number of RSUs reported represents the maximum possible number of shares that are eligible for vesting, which is 150% of the number of shares at target payout. One-fourth of these RSUs are eligible to vest on each of the first four anniversaries of the grant date.
