- (3) The price reported is the weighted average price of multiple transactions ranging from \$18.15 to \$18.30. The reporting person hereby undertakes to provide upon request to the SEC, the Issuer or a security holder of the Issuer the number of Class A Common Stock and the prices at which the transactions were effected.
- (4) The reported amount consists of 6,925 restricted share units and 10,162 common shares of beneficial interest. The restricted share units are to be settled in an equal number of common shares of beneficial interest upon vesting.
