(TSX: ONC, NASDAQ: ONCY) (Oncolytics) has been granted Canadian Patent 2,415,750 entitled Methods for Preventing Reovirus Recognition for the Treatment of Cellular Proliferative Disorders. The claims describe methods for preventing reovirus recognition by the host immune system, while concurrently or subsequently administering reovirus, resulting in substantial lysis of the proliferating cells.
