(1) Restricted shares granted pursuant to Cintas Corporation's 2005 Equity Compensation Plan.

Restrictions on restricted shares granted pursuant to Cintas Corporation's 2005 Equity Compensation Plan and previously reported on Form 4 have lapsed. Of the total 5,000 shares that have vested, the reporting person has transferred 1,373 of these shares to satisfy tax withholding.
