(1) On February 1, 2011, the trust established under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plan of 2005 (the "Compensation Plan Trust") purchased 1,000 shares of Class A Common Stock at prices ranging between \$19.61 and \$19.69 per share for the benefit of Mr. Myers.

(2) This figure includes 99,700 restricted shares of Class A Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan.

(3) Mr. Myers is the direct beneficial owner of 117,950 shares of Class A Common Stock, including the 99,700 restricted shares referenced in footnote 2. In addition, he is the indirect beneficial owner of 1,000 shares of Class A Common Stock owned by the Compensation Plan Trust for the benefit of Mr. Myers.
