(1) On December 30, 2011, the Trust Established Under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plan dated 1/1/2000 (the "Plan") distributed 1,190 shares of Common Stock to Willing L. Biddle (the "Reporting Person"), a participant in the Plan. This resulted in no change in the number of shares beneficially owned by the Reporting Person.

(2) On January 3, 2012, the Issuer entered into an agreement with the Reporting Person whereby the Reporting Person was granted a restricted stock award of 100,000 shares of Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").

(3) This figure includes restricted shares of Common Stock issued pursuant to the Restricted Stock Award Plan. Including the January 3, 2012 grant of restricted stock reported on this Form 4, the Reporting Person is the owner of 937,500 restricted shares of Common Stock.

Mr. Biddle is the direct beneficial owner of 2,251,055 shares of Common Stock, including the 937,500 restricted shares noted in Footnote 3. In addition, he is the indirect beneficial owner of 37,147 shares of Common Stock, of which 4,395 shares are owned by the two Trusts Established Under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plans of 2000 and 2005, 2,307 shares are owned by the Willing L. Biddle IRA for the benefit of Mr. Biddle, 5,163 shares are owned by the P.T. Biddle (Deceased) IRA for the benefit of Willing Biddle, 23,657 shares are owned beneficially and of record by Catherine U. Biddle, Mr. Biddle's wife, 555 shares are owned by the Catherine U. Biddle IRA for the benefit of Catherine U. Biddle, and 1,070 shares are owned by the Charles and Phoebe Biddle Trust UAD 12/20/93 for the benefit of the Issue of Willing L. Biddle (the "Biddle Trust"). Mr. Biddle and Charles J. Urstadt are the sole trustees of the Biddle Trust.
