The reporting person will provide, upon request by the SEC staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.

(3) Represents the sale of shares in [ 149 ] separate transactions, ranging in price from \$13.48 to \$13.56, resulting in a weighted average sale price per share of \$13.53.
