**Item 2.01 Completion of Acquisition or Disposition of Assets.**

On May 9, 2007 the registrant purchased all tangible and intangible of Euleess Gold and Silver, Inc. located in Euleess, Texas. The purchase price paid for these assets totaled \$ 1,000,000 including \$ 600,000 in cash and a two year note in the amount of \$ 400,000. The registrant has opened a new retail store in the former Euleess Gold & Silver facility in Euleess, Texas and operates under the name Dallas Gold & Silver Exchange.

**Item 2.03 Creation of a direct Financial Obligation or an Obligation under an Off-Balance Arrangement of a Registrant.**

On May 10, 2007 the registrant entered into an amendment to its credit facility with Texas Capital Bank. The amendment increased borrowings allowed under this facility from \$ 3,000,000 to \$ 3,600,000. The additional funds were initially used for the transaction described in item 2.01 described herein.
