These 1,972 shares are not sold on the open market and become Revlon, Inc. treasury shares. Of the remaining 37,917 unvested restricted shares that Mr. Mammone was granted on November 16, 2006, 13,125 shares will vest on January 2, 2008, 13,125 shares will vest on July 1, 2008, 5,833 will vest on November 16, 2008 and 5,834 will vest on November 16, 2009.
