- (1) Represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of federal and state withholding taxes due upon the July 1, 2008 vesting of 13,125 of the 70,000 shares of restricted stock Mr. Mammone was granted on November 16, 2006. These 4,437 shares are not sold on the open market and become Revlon, Inc. treasury shares.
