  - (1) Disposed of pursuant to a merger agreement providing for the merger of the Issuer and UnitedGlobalCom, Inc. (the merger involving the Issuer, the "Merger") with wholly-owned subsidiaries of Liberty Global, Inc. ("LGI") in exchange for an equivalent number of shares of LGI Series A Common Stock.
  - (2) The option was acquired pursuant to anti-dilution provisions in the non-employee director incentive plan of Liberty Media Corporation ("LMC") in connection with the spin off of the Issuer from LMC on June 7, 2004 and subsequently adjusted as to exercise price and

number of shares pursuant to anti-dilution provisions in the non-employee director incentive plan of the Issuer in connection with the Issuer's rights offering effective August 23, 2004 (the "Rights Offering").

- (3) The option was 100% vested.
- (4) The option was assumed by LGI in the Merger and replaced with an option to purchase an equivalent number of shares of LGI Series A Common Stock at the same exercise price.
- (5) The option was adjusted as to exercise price and number of shares pursuant to anti-dilution rights in the non-employee director incentive plan of the Issuer in connection with the Rights Offering.
