- (1) The options were granted under the Key Energy Group, Inc. 1997 Incentive Plan and are fully vested and exercisable.
The option was granted under the Key Energy Group, Inc. 1997 Incentive Plan and is exercisable in three installments as follows: the first installment for 5,000 shares became exercisable on March 15, 2008; the second installment for 2,500 shares becomes exercisable on March 15, 2009; and the third installment for 2,500 shares becomes exercisable on March 15, 2010.
- (2) The option was granted under the Key Energy Group, Inc. 1997 Incentive Plan and is exercisable in three equal annual installments. The first installment became exercisable on August 22, 2008; and the next two installments become exercisable on August 22, 2009 and August 22, 2010.
- (3) The option was granted under the Key Energy Services, Inc. 2007 Equity and Cash Incentive Plan and is exercisable in four equal annual installments beginning on April 10, 2009.
- (4) The option was granted under the Key Energy Services, Inc. 2007 Equity and Cash Incentive Plan and is exercisable in four equal annual installments beginning on June 30, 2009.
The option was granted under the Key Energy Services, Inc. 2007 Equity and Cash Incentive Plan and is exercisable in four annual installments as follows: 5,188 shares on August 21, 2009; 5,187 shares on August 21, 2010; 5,188 shares on August 21, 2011; and 5,187 shares on August 21, 2012.
- (5) Represents unvested award of restricted stock shares granted under the Key Energy Services, Inc. 2007 Equity and Cash Incentive Plan.
The restricted stock shares will vest in four annual installments as follows: 4,051 shares on August 21, 2009; 4,050 shares on August 21, 2010; 4,051 shares on August 21, 2011; and 4,050 shares on August 21, 2012.
- (6) Each phantom share award granted December 22, 2006 shall vest in four equal annual installments on the anniversary of the grant date. The vested phantom shares are payable solely in cash within 20 days of the vesting date.
- (7) Each share of phantom stock is the economic equivalent of one share of KEG common stock.
