 On November 25, 2008, the Reporting Person sold 86,504 shares of Common Stock of iStar Financial Inc. (NYSE: SFI) in an open market sale at a price of \$1.1392 per share. The Form 4 that was filed on November 28, 2008 reporting this sale included an erroneous  
 (1) code in Table I, Column 4, indicating this was an "Acquisition" rather than a "Disposition" of shares. This amendment on Form 4/A corrects that code reference in Table I, Column 4. Following this sale, the Reporting Person owns an aggregate of 10,000 shares of iStar Common Stock, which are held directly.  
 (2) The Reporting Person also owns a total of 11,000 shares of iStar preferred stock and a total of 1,177,933 Restricted Stock Units, representing the right to receive an equivalent number of shares of iStar common stock if and when the Units vest.
