- On January 14, 2010, the Issuer effected a reverse stock split after which any shareholder that held less than one share will receive \$5.15 for each pre-split share. - (2) These shares are owned directly by Gratco, LLC and indirectly by David C. Pratt Irrevocable Grantor Retained Annuity Trust, dated 12/1/92, which is the sole voting member of Gratco, LLC. Mr. Pratt is the manager of Gratco, LLC. The shares are owned indirectly by Mark R. Gale as President of Calco, Inc., the trustee of the trust. Mr. Gale disclaims beneficial ownership of the assets or income of the trust.
