- On May 1-3, 2013, a total of 80,246 shares of iStar common stock (26,749 shares on May 1, 26,749 shares on May 2 and 26,748 shares on May 3) were sold on behalf of the Reporting Person, Mr. Jay Sugarman, at the sales prices set forth in this Form 4 in open market transactions pursuant to a Rule 10b5-1 sales plan adopted by the Reporting Person on March 22, 2013. Following the transactions reported in this Form 4, the Reporting Person is the direct beneficial owner of 2,571,676 shares of iStar common stock and the indirect beneficial owner of 44,544 shares of iStar common stock owned by his spouse.
