The 6.5633 dividend equivalent rights being reported reflect 3.3162 dividend equivalent rights at \$52.18 per RSU credited to the Reporting Person's account on 01/06/10; and 3.2471 dividend equivalent rights at \$53.29 per RSU credited to the Reporting Person's account on 04/07/10. These RSUs cliff vested on 04/20/10, at which time the vested shares were delivered to the Reporting Person.
