- (1) Represents performance-based Restricted Stock Units (RSUs), each representing the right to receive, following vesting, one share of common stock. The resulting shares acquired upon vesting of the RSUs is contingent upon the achievement of pre-established performance metrics over a 3 year period beginning 1-1-2014 and ending on 12-31-2016 (the "Performance Period"), provided that the Reporting Person remains employed by the Issuer on the date following the Performance Period that the Compensation Committee of the Issuer's Board of Directors determines that the performance goals for the final year of the Performance Period have been satisfied. If employment terminates sooner, the RSUs will be forfeited unless termination of employment occurs because of death or, subject to certain service requirements, disability or normal or early retirement, in any of which events the RSUs may vest in whole or in part. The RSUs were granted under the Issuer's 2009 Equity Compensation Program.
- (2) D: Includes the RSUs reported in Column 4. Also Mr. Shara's direct holdings include 2,109 shares acquired as part of the Company's DRP. Also included are 1,753 shares held as custodian for son including 36 shares acquired in the DRP; Mr. Shara's total also includes 41,718 shares subject to restricted stock awards that have not yet vested. I: Includes 693 shares held by a family partnership of which Mr. Shara and his wife are general partners. In this total are 15 shares acquired as part of the Company's DRP.
