(1) Deferred stock award granted pursuant to State Street Corporation 1997 Equity Incentive Plan.

The reporting person indirectly beneficially owns 1,538 shares of State Street common stock through State Street Corporation's 401(k) plan, as of February 1, 2005. The plan accounts for interest in units of shares and a small amount of cash. As a result the number of underlying shares may fluctuate from time to time.

(3) Employee Stock option grant pursuant to State Street Corporation 1997 Equity Incentive Plan.

(4) Options become exercisable in 25% installments over a four-year period commencing on March 2, 2006.

These rights, which represent the right to receive cash in an amount equal to the fair market value of the underlying common stock, had previously been reported in Table 1. They are held under State Street Corporation's 401(k) Restoration and Voluntary Deferral Plan, as of February 1, 2005, and will be settled upon reporting person's retirement.
