- (1) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan.

- (3) 2000 Stock Incentive Plan: This option vests in four equal installments beginning on January 17, 2003.
