- (1) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan.  
2000 Stock Incentive Plan: 15,154 restricted shares were awarded pursuant to H.B. Fuller Company's 2000 Stock Incentive Plan.
