On February 25, 2009, the Management Compensation Committee of NASDAQ OMX's Board of Directors approved the settlement of the PSU grant. The shares underlying the PSUs will vest on December 31, 2011.
  - (2) Represents (i) 10,870 unvested shares of restricted stock, (ii) 16,527 unvested shares underlying PSUs and (iii) 4,479 shares purchased under the Employee Stock Purchase Plan.
