(the "Issuer"), all in accordance with the requirements of the Limited Partnership Agreement of the Operating Partnership.
- (1) Partnership (the "Operating Partnership"), and subsequently redeemed the 217 Common Units for 217 shares of the common stock of Digital Realty Trust, Inc. (the "Issuer"), all in accordance with the requirements of the Limited Partnership Agreement of the Operating Partnership.

Common Units are redeemable for cash based on the fair market value of an equivalent number of shares of the Issuer's common stock, or, at the election of the Issuer, for an equal number of shares of the Issuer's common stock, subject to adjustment in the event of stock splits, stock dividends, issuance of stock rights, specified extraordinary distributions or similar events.
