- (1) Received in exchange for 5,250 common bearer shares of PARIS RE Holdings Limited ("PARIS RE") in connection with the merger of PARIS RE with and into PartnerRe Holdings II Switzerland GmbH, a wholly owned subsidiary of PartnerRe Ltd. (the "Merger") at a conversion ratio of 0.3018. On the effective date of the Merger, the closing price of PARIS RE's common bearer shares was 15.06 Euros per share, and the closing price of PartnerRe Ltd's common shares was \$76.01 per share.
