- Under the directors' compensation policy for non-employee directors of American Public Education, Inc. (the "Company"), the Company's compensation committee annually grants each non-employee director an award of restricted common stock of the Company (1) having a value of \$41,750 on the date of grant. The shares vest on the earlier of May 11, 2013 and immediately prior to the 2013 annual meeting of stockholders. Because Mr. Andersen did not begin his term of service along with the other directors of American Public Education, Inc. on May 11, 2012, his award has been prorated accordingly to account for his comparatively shorter term of service.
