  - (1) The reporting person acquired the shares pursuant to a Reorganization and Purchase and Sale Agreement, dated as of March 27, 2012, among Continental Resources, Inc. ("Continental"), Wheatland Oil Inc. ("Wheatland") and the shareholders of Wheatland. The reporting person owns 75% of the issued and outstanding shares of Wheatland and 75% of the value of the total consideration for the assets of Wheatland acquired by Continental is \$234,969,431.
  - (2) Includes 68,000 shares of restricted common stock which vest on October 5, 2012; 67,000 shares of restricted common stock which vest on November 15, 2013; and 58,340 shares of restricted common stock which vest on November 15, 2014.
