Following his retirement as an employee of the Company on May 31, 2013, Mr. Molbeck became a non-employee director and received a pro-rated grant of 1,800 shares (equal to the pro-rated retainer of \$78,027.40 divided by \$43.34, the closing price on August 21, 2013, the date of the grant).
