**Item 1.01. Entry into a Material Definitive Agreement**

On March 18, 2005, Exide Technologies issued 10<sup>1</sup>/<sub>2</sub>% Senior Secured Notes due 2013 and Floating Rate Convertible Senior Subordinated Notes due 2013. In connection with the offering of the 10<sup>1</sup>/<sub>2</sub>% Senior Secured Notes due 2013, on March 15, 2005, Exide Technologies entered into a purchase agreement and on March 18, 2005, Exide Technologies entered into a registration rights agreement and an indenture.
