(hereinafter called Mitsui) today announced that Mitsui and Unisys Corporation in the United States (hereinafter called Unisys) have agreed that they will revise their current joint possession relationship with respect to Nihon Unisys Ltd. (hereinafter called NUL) once the sale and transfer by Unisys of its stake in NUL has taken place.

While the joint possession relationship of NUL stake between Mitsui and Unisys would end, the relationship between NUL and Unisys regarding the product supply and the technical collaboration will remain unchanged.
