**Item 7.01. Regulation FD Disclosure**

Pursuant to the Company's existing Stock Repurchase Program, as extended from time to time, the Board of Directors has authorized the repurchase of up to 5,047,423 shares of the Company's common stock. In accordance with this authorization, the Company had repurchased 4,239,134 shares of its common stock as of June 30, 2010. The current share repurchase authorization will expire on November 15, 2010, unless extended.

During June 2010, the Company repurchased 194,197 shares of its common stock at an average repurchase price of \$8.71 per share. The maximum number of additional shares that may be repurchased pursuant to the current share repurchase authorization is 808,289 shares. The current share repurchase authorization may be suspended, terminated or modified at any time prior to November 15, 2010 for any reason, including, without limitation, market conditions, the cost of repurchasing shares, the availability of alternative investment opportunities, liquidity, and other factors deemed appropriate.
