On May 10, 2011, Computer Software Innovations, Inc. (the Company) held its Annual Meeting of Stockholders. The common stockholders voted for the election of five (5) directors to serve for terms of one (1) year each, expiring on the date of the 2012 Annual Meeting of Stockholders or until their successors have been duly elected and qualified. The results of the voting in these elections are set forth below.
