**Panasonic to Accept European Commission Decision on Refrigeration Compressors**

**Osaka, Japan, December 22, 2011** Panasonic Corporation (NYSE:PC/TSE:6752, Panasonic ) announced today to accept the European Commission ( Commission ) Decision imposing a fine on Panasonic of 7,668,000 on refrigeration compressors that the Commission announced on December 7, 2011.

There shall be no material effect on the financial outlook for the fiscal year ending March 31, 2012 as a result of this payment.

It is the policy of Panasonic to comply with all applicable laws and regulations, including antitrust regulations. The Company takes this matter seriously and will make every effort to maintain the public's confidence.
