**Item 7.01 Regulation FD Disclosure.**

On January 3, 2012, The AES Corporation ( AES or the Company ) issued a press release announcing that its subsidiary, AES Eastern Energy Limited Partnership ( AES Eastern Energy ), has filed for bankruptcy protection. AES Eastern Energy and its affiliates are indirect, wholly owned subsidiaries of the Company. AES is not included in the bankruptcy filing.

The Company s guidance metrics were updated on November 4, 2011. The Company is not updating its guidance at this time other than to note that, while still under review, the bankruptcy filing described above does not impact the Company s diluted earnings per share, adjusted earnings per share or cash flow for the year ending December 31, 2011. The Company s review of its 2011 fourth quarter and full year financial results is not complete and the Company intends to report its results in February of 2012.

A copy of the press release is being furnished as Exhibit 99.1 attached hereto and is incorporated by reference herein. Such information is furnished pursuant to Item 7.01 and shall not be deemed filed for any purpose, including for the purposes of Section 18 of the Exchange Act, or otherwise subject to the liabilities of that Section. The information in this Current Report on Form 8-K shall not be deemed incorporated by reference into any filing under the Securities Act or the Exchange Act regardless of any general incorporation language in such filing.
