**NU-NSTAR Merger Receives Approval in Connecticut**

*Massachusetts approval pending*

Connecticut's Public Utilities Regulatory Authority (PURA) issued its final decision today approving the merger of NU and NSTAR and related agreements that will provide benefits to customers following the close of the merger. It was one of two required state approvals; a decision in Massachusetts is still pending. The companies have requested a decision by the Massachusetts Department of Public Utilities on April 4 to facilitate the merger schedule.

We are very pleased by the Public Utilities Regulatory Authority's approval of our merger, said Chuck Shivery. Today's announcement reflects additional positive momentum toward the timely completion of our merger.

The approval from Connecticut regulators is a crucial milestone in this merger process and brings us one step closer to delivering substantial benefits to customers, employees and shareholders, noted Tom May. We are thankful for the hard work of the Public Utilities Regulatory Authority. This keeps us on track as we move closer to achieving our goal of finalizing the merger by mid-April.
