One-quarter of the RSUs granted to each person vests in four equal annual installments commencing one year after the date of grant. The common shares underlying the RSUs are issued as vesting occurs, so the recipients do not have voting or dividend rights with respect to any common shares underlying the RSUs until vested. The recipients cannot sell or transfer the RSUs or any interest therein, except by will or by the laws of descent and distribution. If a recipient's service with inContact is terminated because of his or her resignation or due to Just Cause, as defined in the Change in Control Severance Compensation Policy adopted by inContact in August 2011, any common shares underlying the RSUs that have not vested will expire and be forfeited for no cash or other consideration. In the event of termination without Just Cause (including death or disability) or a Change in Control as defined in the Change in Control Severance Compensation Policy, vesting of all unvested common shares underlying the RSUs will accelerate, so that common shares are fully vested as of the date immediately prior to the date of termination.
