The following is a message to employees of the CP posted onto CP's internal employee website on November 20, 2015:

Dear colleagues:

As you have heard, CP has made an offer to Norfolk Southern Corp. (NSC) that we believe will be in the best long-term interest for CP. The business combination we are proposing allows both franchises to enhance their potential in terms of market reach, it allows shippers and customers the opportunity for faster transit times and premium service, and we think will maximize value for shareholders.

There have been several rumours in the media about headquarter relocation. Any talk of relocation is entirely premature and speculative in nature. That said, Canadian Pacific has no plans to move its headquarters outside of Canada.

There will be many reports in the media about our talks, but it is important that as we head into winter and the holiday season, you all stay focused on your work and keep the railroad running in top form. We have had three solid quarters at CP this year, and nothing you read or see in the media should take your attention away from where it needs to be on running the safest, most efficient operation we can.

I will keep you updated on this story as the process moves forward.
