EXPLANATORY STATEMENT.

This Amendment No. 3 to Schedule 13D (**Amendment No. 3**) relates to shares of Common Stock of the Issuer and is being filed on behalf of the Reporting Persons. This Amendment No. 3 amends and supplements the Amendment No. 2 to Schedule 13D previously filed with the Securities and Exchange Commission on December 3, 2015 (**Amendment No. 2**), the Amendment No. 1 to Schedule 13D previously filed with the Securities and Exchange Commission on November 12, 2015 (**Amendment No. 1**), and the initial Schedule 13D previously filed with the Securities and Exchange Commission on October 10, 2014 (the **Initial Schedule 13D** , together with Amendment No. 1, Amendment No. 2, and this Amendment No. 3, the **Schedule 13D**).

This Amendment No. 3 amends Item 4 to delete the following paragraph, in its entirety, from Item 4: Wende S. Hutton, a member and manager of the General Partner, serves as the representative for the Reporting Persons on the Issuer s board of directors.

This revision has been made to reflect the fact that on December 31, 2015, Ms. Hutton resigned from her position on the Issuer s board of directors, and therefore, no longer serves as a representative for the Reporting Persons on the Issuer s board of directors.

ITEM 1. SECURITY AND ISSUER.

This Statement on Schedule 13D relates to shares of common stock, par value \$0.001 per share (the **Common Stock**), of Dermira, Inc., a Delaware corporation (the **Issuer**). The address of the Issuer s principal executive office is 2055 Woodside Road, Redwood City, California 94061.

ITEM 2. IDENTITY AND BACKGROUND.

Item 2 (a) (c). This statement is being filed by the following persons:

(i) Canaan VIII L.P., a Cayman Islands exempted limited partnership (the **Partnership**); and

(ii) Canaan Partners VIII LLC, a Delaware limited liability company (the **General Partner**) and the general partner of the Partnership.

The Partnership and the General Partner are sometimes individually referred to herein as a **Reporting Person** and collectively as the **Reporting Persons**.

Each of the Reporting Persons is principally engaged in the business of investing in securities. The business address and principal executive offices of the each of the Reporting Persons are c/o Canaan Partners, 285 Riverside Avenue, Suite 250, Westport, Connecticut 06880.

Item 2 (d) (e). During the last five years, none of the persons identified in this Item 2 has been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors), or has been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violations with respect to such laws.

Item 2 (f). The Partnership is a Cayman Islands exempted limited partnership. The General Partner is a Delaware limited liability company.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

On October 2, 2014, the Registration Statement on Form S-1 filed with the Securities and Exchange Commission by the Issuer in connection with its initial public offering of 7,812,500 shares of Common Stock of the Issuer (the **IPO**) was declared effective. The closing of the IPO took place on October 8, 2014, and at such closing the Partnership purchased an aggregate of 49,276 shares of Common Stock of the Issuer (the **Shares**) at the IPO price of \$16.00 per share, and the Partnership's 1,708,040 shares of the Issuer's Series A Preferred Stock, 469,878 shares of the Issuer's Series B Preferred Stock, and 272,955 shares of the Issuer's Series C Preferred Stock were automatically converted into, in the aggregate, 2,450,873 shares of Common Stock.

The Partnership used its own assets to purchase the Shares.

ITEM 4. PURPOSE OF TRANSACTION.

The Reporting Persons acquired the Shares for investment purposes in the ordinary course of their business of investing in securities for their own accounts or for one or more accounts over which the Reporting Persons have investment or voting power. The Reporting Persons reserve the right to formulate plans and/or make proposals, and take such actions with respect to their investment in the Issuer, including, subject to applicable law, (i) to hold the Shares as a passive investor or as an active investor (whether or not as a member of a group with other beneficial owners of Shares or otherwise), (ii) to acquire beneficial ownership of additional shares in the open market, in privately negotiated transactions or otherwise, (iii) to dispose of all or part of its holdings, (iv) to take other actions which could involve one or more of the types of transactions or have one or more of the results described in this Item 4 of Schedule 13D, or (v) to change its intention with respect to any or all of the matters referred to in this Item 4.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

Item 5 (a) and (b). As of December 3, 2015, the Partnership may be deemed to beneficially own 1,500,089 shares of Common Stock, representing approximately 5.0% of the Issuer's common stock outstanding, which shares of Common Stock are held directly by the Partnership (the **Partnership Shares**). The Partnership has sole voting, investment and dispositive power with respect to the Partnership Shares.

As of December 3, 2015, the General Partner may be deemed to beneficially own 1,500,089 shares of Common Stock, representing approximately 5.0% of the Issuer's common stock outstanding, which consists of the Partnership Shares. The General Partner has sole voting, investment and dispositive power, through its control of the Partnership, with respect to the Partnership Shares.

Item 5 (c). Except as set forth in the attached Annex I to this Schedule 13D, no Reporting Person has effected any transaction in shares of Common Stock in the last 60 days.

Item 5 (d). Except as set forth in this Schedule 13D, to the knowledge of the Reporting Persons, no person had the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, securities covered by this Schedule 13D.

Item 5 (e). Not applicable.

ITEM 6. CONTRACTS, ARRANGEMENTS, UNDERSTANDINGS OR RELATIONSHIPS WITH RESPECT TO SECURITIES OF THE ISSUER.

Except as otherwise set forth in this Schedule 13D, there are no contracts, arrangements, understandings or relationships among the persons named in Item 2 or between such persons and any other person with respect to any securities of the Issuer.
