**Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

The Dow Chemical Company (the Company or Dow) today announced changes to the Company's current executive leadership appointments, effective immediately.

On February 2, 2016, Mr. James R. Fitterling was appointed President and Chief Operating Officer. He succeeds Mr. Andrew N. Liveris as President with Mr. Liveris continuing as the Company's Chief Executive Officer and Chairman. Mr. Fitterling will continue to report to Mr. Liveris in his position as Chief Executive Officer and Chairman.

Mr. Fitterling will continue to be accountable for all of Dow's businesses, except Dow AgroSciences, and will have accountability for driving the successful completion of the proposed DowDuPont merger and subsequent intended spin-offs of DowDuPont into three independent public companies.

Mr. Fitterling is 54 years old and joined Dow in 1984. Mr. Fitterling has served in a variety of roles during his career with the Company, including as Vice President Corporate Development from 2009 to August 2010; Dow Executive Vice President and President, Plastics and Hydrocarbons August from 2010 to September 2011; Executive Vice President and President, Feedstocks & Energy and Corporate Development from September 2011 to September 2012; Executive Vice President, Feedstocks, Performance Plastics, Asia and Latin America from September 2012 to December 2013; Executive Vice President, Feedstocks, Performance Plastics and Supply Chain from December 2013 to October 2014 and he served as Vice Chairman, Business Operations since October 2014.

There is no arrangement or understanding between Mr. Fitterling and any other person pursuant to which Mr. Fitterling was appointed as President and Chief Operating Officer of the Company. There are no transactions in which Mr. Fitterling has an interest requiring disclosure under Item 404(a) of Regulation S-K.
