### **Preliminary Milestones Reached in DowDuPont Transaction**

#### **March 2, 2016**

By now you have probably seen the communication for the site structure of the intended agriculture company following the planned separation of DowDuPont into three independent, publicly traded companies. In this announcement, we also confirmed that the intended Material Science company, to be named Dow, will remain headquartered in Midland, Michigan, and maintain global business centers in other U.S. and global locations.

This week marked another important milestone with the submission of the S-4 filing for the DowDuPont transaction. The Form S-4 is required by the Securities and Exchange Commission (SEC) to disclose important information to shareholders related to mergers, acquisitions or exchange offers. We encourage you to review the slides that the Dow and DuPont Investor Relations teams have prepared to learn more about the very real value this powerful combination will deliver through three new companies.

The planned transaction remains on track for closing in the second half of 2016, subject to satisfying the necessary closing conditions and required regulatory approvals. Both Dow and DuPont have dedicated teams that are partnering together to plan for the three intended business portfolios and ensure synergy capture.

While important work continues to progress to close the transaction, we are still obligated to deliver on the Company's 2016 financial plan, said **Andrew Liveris**. Please maintain resolute focus on delivering against our shared financial and safety targets.

### **Important Information About the Transaction and Where to Find It**

In connection with the proposed transaction, on March 1, 2016 DowDuPont Inc. (f/k/a Diamond-Orion HoldCo, Inc.) (DowDuPont), filed with the Securities and Exchange Commission (SEC) a preliminary registration statement on Form S-4 that includes a joint proxy statement of The Dow Chemical Company (Dow) and E. I. du Pont de Nemours and Company (DuPont) and that also will constitute a prospectus of DowDuPont. These materials are not final and may be amended. Dow, DuPont and DowDuPont may also file other documents with the SEC regarding the proposed transaction. This document is not a substitute for the joint proxy statement/prospectus or definitive registration statement or any other document which Dow, DuPont or DowDuPont may file with the SEC.
