As permitted under the terms of the Second Amended and Restated 2002 Stock Option Plan (the "Plan"), the reporting person surrendered

(1) 14,500 shares of common stock owned by the reporting person as partial consideration of the exercise price of the employee stock options and satisfaction of tax withholding obligations arising from the exercise of such options.

(2) Pursuant to the terms of the Plan, the price was determined by reference to the average of the closing bid and ask prices on the last trading day prior thereto.
