The two reported transactions involved an amendment of a previously reported option, resulting in the reporting, solely for Section 16 purposes, of a deemed cancellation of the "old" option and the deemed grant of a replacement option. The "old" option grant, effective as of March 19, 2007, exceeded the applicable limitation on the number of shares permitted to be granted under the Equity Award Plan for Employees and Officers (the "Plan") and was void ab initio with respect to such excess shares. No terms or conditions of the "old" option were amended other than to reflect the reduction of the number of shares underlying the option from 450,000 to 270,000 pursuant to such limitation on the number of shares permitted to be granted under the Plan. The grant date of the option remains March 19, 2007.

(2) 20% of the option vests on March 17th of each year beginning in 2008 and ending in 2012.
